October Meetings Highlights:

The following were approved at NDAR's committee and Board of Directors Meetings held on October 23-24:

Reconfirmed that NDAR will pay off our half portion of mortgage on Realtors® office building jointly owned with the Bismarck Mandan Board of REALTORS® in November.

Changing name of Education Committee to the Professional Development Committee.

Membership Committee revamped purpose statement of the committee and will be redesigning the Membership Brochure for new or potential members. Committee developed three goals that they will focus on this year and committee members are challenged to meet with 10 people to spark an interest in getting involved in the association. Committee also approved a reporting form to be used by local boards when doing reports for this committee. Four Life Member applications were approved by the Membership Committee: *Chuck Walker*, Coldwell Banker; *Keith Jones*, Prudential Preferred Properties; *Reuben Liechty*, Reuben Liechty REALTORS®; and *Char Broten*, Reuben Liechty REALTORS®.

RPAC Fundraising Committee set goals for the 2008 year and created a taskforce to look into having a ND Hall of Fame for RPAC major donors. Also planning to have NAR Staff doing some RPAC fundraising training at the January meetings.

Fiscal Year Taskforce recommended a bylaws change to move the Budget year of the Association to a calendar year versus the September through August fiscal year. (This will be on the agenda for a General Membership Meeting at the January Meetings in Bismarck). Also moved the Leadership Year of the Association to December 1 through November 30 to be more in line with NAR – elections and installation will still occur at the State Convention in September.

Perry Weekes, Bismarck, was recognized for his years of service as a National Director for the NDAR – his term will be finished at the NAR Convention in Las Vegas and *Dewey Uhlir*, Fargo, will then serve a three year term as elected by the Board of Directors.

PROPERTY TAX RELIEF-INCOME TAX CREDIT

During the last biennium (2005-2007), the North Dakota economy was strong, enabling the State to offer \$115 million in property tax relief. The relief is the result of a law passed by the 2007 Legislature and signed by Governor Hoeven. The relief is provided to homeowners, land owners, and commercial property owners.

NAR Names Lawrence Yun Chief Economist

The National Association of REALTORS has named Lawrence Yun chief economist and senior vice president of research. Yun has served at NAR since 2000, most recently as vice president and senior economist.

Yun has been chief forecaster at NAR for several years and pioneered the development of the Commercial Leading Index after helping develop the residential Pending Home Sales Index. He is a member of the National Association of Business Economists and the Harvard University Industry Economists Council.

In demand as a speaker at many industry and economic conferences on housing trends and forecasting, he has delivered major addresses at Florida State University and Vanderbilt University, and has participated on forecasting panels at The Wall Street Journal, USA Today, the Blue Chip Consensus, Bloomberg and others.

Yun has worked as an economic consultant to the U.S. Department of Veterans Affairs and the U.S. Department of Education. While a research associate at the University of Maryland for three years, Yun developed the graduate economics curriculum for and taught free market economics in the former Soviet Union as that country transitioned from communism to a free-market system.

He also taught economics at the graduate level at the University of Maryland, where he received his Ph.D. in economics in 1995. He received a B.S. degree in mechanical engineering from Purdue University in 1987.
