Statewide Housing Conference Feb 16-17

North Dakota Housing Finance Agency will host the 25th Statewide Housing Conference on Feb. 16-17, 2016, at the Ramkota Hotel in Bismarck, ND.

The North Dakota Real Estate Commission has approved the event for eight hours of continuing education if real estate agents attend the full conference. Agents also have the option to attend only one day of the event earning five hours for Tuesday attendance or three hours for Wednesday attendance.

First Task for NAR Lab: Better Smart Home Devices

A new lab at the NAR building in Chicago is studying smart home devices with the aim of making them better. The goal is to test the devices and make recommendations to manufacturers and research institutions on what would make the devices better from a real estate professional's standpoint. The lab is a top story in The Voice for Real Estate for the week of January 25. The news video also looks at the surge in existing-home sales in December, the life sentence handed down to the killer of an Arkansas real estate agent, and recent court rulings on so-called ephemeral messaging, which is text messaging through apps like Snapchat that go away after a few seconds.
