The Committee Purpose was reviewed.

Course Updates:

Mandatory Topic Recommendation: The recommended 3-hour course has 1 hour each on Advertising, Agency and Professional Courtesy. Chair Dave briefly reviewed a course outline he developed. Jill Beck will be addressing the recommended topics when it comes up as an agenda item at ND Real Estate Commission meeting.

Google class update: An email from G. Williams James, a Google presenter, was reviewed. There was group consensus that the cost doesn't seem too prohibitive.
