2. The minutes of the February 6, 2017 Conference Call were approved. **M/S/C**
3. Haskell reviewed the status of the 2017 RPAC President Cup Goals. All goals but the total 2017 fundraising goal of \$152,000 have been met.
4. Nancy Willis reviewed the status of 2017 RPAC Triple Crown Goals. Additional requirements than the President’s Cup goals are in the works.
5. Haskell reported that 80% of Board/committee members have made a contribution.
6. Haskell reviewed NDAR specific goals and their status:

b. Participation: 75%	Actual: 49%
c. Major Donors: 50	Actual: 25
d. President Club: 28	Actual: 23
e. Capital Club: 88	Actual: 35
f. 99 Club: 270	Actual: 109
7. The remainder of the meeting was spent participating in a phone bank. Participants were: Karin Haskell, Amy Hullet and Mary Shelkey-Miller, Bismarck; Kevin Fisher, Deb Nichols and Jodi Tollefson, Fargo; Rita Schuster, Grand Forks; Diane Loper and Mike Swartz, Jamestown; Tami Dunn and Sue Heth, Minot.

The phone bank raised \$4,758 and additional checks from board and committee members making their contributions added up to \$7,308 for the afternoon. Call backs resulted in an additional \$750 for a total of \$8,058! More was expected to come in.

Awards went to: 1) Kevin Fisher – largest single contribution (\$500); 2) Karin Haskell – largest total contributions (\$925) and 3)/4)Jodi Tollefson – first contribution/most contributors (11).
