17 downs, prepaid expenses, home warranty and other such monetary considerations. If competing offers
18 include escalation provisions, such offers' maximum purchase price may be considered in determining
19 escalated purchase amount subject to Buyer's maximum purchase price stated above.

20 d. **Documentation of Proof:** If escalation is set forth with this Addendum, the Seller(s) agrees to
21 provide sufficient proof to Buyer(s) of the competing offer. Seller(s) to provide a copy of the competing
22 PURCHASE AGREEMENT, without change. Seller(s) may remove prospective names from the offer,
23 but may not remove financial terms, including price and concessions.

24 **BROKERAGE DISCLAIMER:** Buyer(s) acknowledges and agrees that the PURCHASE AGREEMENT and
25 this Escalation Addendum are at the Buyer's discretion. Buyer(s) agrees to hold all Agent(s) and Broker(s)
26 harmless regarding the use and operation of the Escalation Addendum as set forth herein.

27 **Buyer(s) agrees to present this Addendum with the above stated PURCHASE AGREEMENT for**
28 **consideration.**
